

# Letter from ron andrews PRESIDENT

This past year has been monumental for the Pacific Art League (PAL). We witnessed a dream come true: The building project was completed and PAL reoccupied the newly renovated and seismically safe space in our historic home at 668 Ramona Street. In June of this year PAL started holding classes in the new facility. Unanimously, all of you who visited expressed very positive reactions. The Board and the PAL staff all thank you. This accomplishment came after nearly six years of committed effort by board members, staff, members and our partners. The "Thank you's" are numerous. However, we are particularly grateful for the partnerships that made this a reality. The critical challenge now is to build on these strengths, agree on a goal for the future, organize our efforts, and move forward. The completion of the building project is the good news. To do this, however, PAL had to take on debt. Now, for the first time, we have a mortgage. This is an additional huge challenge, but one that is realistic. To do this PAL needs more revenue producing activity, more events, more fund raising, an expanded curriculum, increased membership. PAL needs your help and financial support to address this challenge.

I look forward to meeting and working with all of you as we plan for and move into our second century with our mission of "Providing an environment for advancing the expression, appreciation and enjoyment of the arts".

Last but most importantly, we would like to take this opportunity to thank all the members of our wonderful faculty and staff for their dedication and hard work, and to thank our loyal members and students for their support. ## DEVELOPMENT

The Development committee continued to solicit funds for the refurbishing of the new building with the Arts Essentials campaign. It worked with a consultant, Chaud Richards of Netzel & Grigsby. We sent out an annual appeal and followed up with a phonathon. We collaborated with the Events Committee to give a Hard Hat party at the Annual Members Meeting in November. We are grateful to the Lennox Foundation for its generous grant of \$25,000 towards the Arts Essential goals. Simone Sarmet was Chair in 2013 and helped to edit solicitation materials. Ken Brenner and Diana Diamond formed a sub-committee to make individual requests. A partnership was created with Silicon Valley Foundation to allow us to accept planned giving. A letter was sent to members by the President which garnered in some donations. Brad Maihack mentored a group of San Jose State University business students who gave us a comprehensive corporate giving plan which the committee is currently pursuing.

## EXHIBITIONS

This past year was an exciting and challenging year for Exhibitions at the Pacific Art League. We were in the interim location, next door on Forest Avenue for a year and a half, where we had the challenge of holding classes in the same space that functioned as our Main Gallery. This set a precedent for our newly remodeled building, where we are once more simultaneously holding classes and exhibiting wonderful art.

We now have three spaces in which to Exhibit: The Corridor Gallery, the Main Gallery, and the Studio One Gallery. In the month of July, in anticipation of our Grand Opening in September, the events committee (chaired by Josephine Shuster,) planned a "Support PAL" show. At \$100 per art piece to enter and an estimated 175 donations, we believed it would be a tremendous salute to the strong community support that we know exists for the Pacific Art League in our community. Having an Art Gallery that is open to the public is an invaluable asset to Palo Alto.

In the coming year, we plan to restart the rental program, continue with our traditional member and themed shows, and add new ideas to the calendar such as including more Instructor shows and children's exhibits.

We would like to extend a special Thank You to our faithful First Friday followers who attended our openings, even showing up during our long and disruptive construction. Now that we are in our beautiful new space, we look forward to another year of exciting classes surrounded by fabulous art work!

# COMMUNITY OUTREACH

### Community & Outreach After School Art

The Community Outreach Committee began in the spring of 2014, with members recruited this summer. Among its accomplishments to date are liaisons with other arts organizations, and having a solid partnership alliance with University Art, now located in Redwood City and San Jose -- which resulted in a lovely benefit to PAL -- the ability to hold a series of PAL classes at their Redwood City facility, courtesy of University Art.

PAL has also contacted the Palo Alto Chamber of Commerce which resulted in a mutual interest of working together. The committee is now looking to establish additional working liaisons with other arts organizations and museums in the Bay Area, (from San Jose to Burlingame) so that we can all work together to better focus attention on the arts in this region.

#### Treasurer Report on the Financial Results for the Year Ended July 31, 2014



#### Notes to the Financial Statements July 31, 2014 & 2013

#### (1) OPERATIONS AND NONPROFIT STATUS

Pacific Art League of Palo Alto (PAL) was founded in 1921 with a mission to provide an environment for advancing the expression, appreciation and enjoyment of the visual arts through art-focused education classes, workshops, exhibitions and events that are open to the community and members.

PAL is exempt from Federal and State income taxes as an organization formed for charitable purposes under Section 501(c) (3) of the Internal Revenue Code. Donors may deduct contribution made to PAL within the Internal Revenue Code regulations.

#### (2) SIGNIFICANT ACCOUNTING POLICIES

PAL prepares its financial statements in accordance with general accepted accounting standards and principles established by the Financial Accounting Standard Board (FASB). References to U.S. GAAP in these footnotes are to the FASB Accounting Standard Codification.

#### Revenue Recognition

Contracts are recorded over the contract period as services are provided. Unrestricted grants and donations are recorded as revenue when received or unconditionally pledged. Restricted grants and donations are recorded as temporarily restricted cash and net assets when received or unconditionally pledged. Transfers are made to unrestricted net assets as cost are incurred or time restrictions of program restrictions lapse.

Program revenue and all other revenue are recognized when earned. Payments received or made in advance of services being performed are recorded either as deferred revenue or prepaid expenses.

#### Property and Equipment and Depreciation

Purchased property and equipment are recorded at cost. Donated property, equipment and services are recorded at fair market value at the time of the donation. Renewals and betterments are capitalized, while repairs and maintenance are expenses as they are incurred. Depreciation is computed using the straight-line method over the following useful lives:

#### Donated Goods and Services

PAL receives services of professional volunteers and donated goods and services in various aspects of its programs and operations. The value assigned to these services and items, based on the donor's estimate of fair value, has been reflected in the accompanying financial statements as donated goods and services.

#### Unrestricted Net Assets

Unrestricted net assets are those net resources that bear no external restrictions and are generally available for use by PAL. PAL has grouped its unrestricted net assets as funds available to carry on the operations of PAL.

#### Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### (5) LEASING OBLIGATIONS

As part of the building upgrade and retrofitting, explained in Note 6 on Subsequent Events, the authorities have permitted to extend the overall floor space. In order to secure the necessary financing for the retrofitting and expansion, PAL was required to lease a part of the building, meeting the bank's requirement to have a rental income for the coming eight years equal to at least 130% of the finance payments. The lease has been effective as of May 2014 and will cover an initial period of eight years after which an optional extension of two periods of 5 years exist. A tenant improvement allowance of \$366,052 was negotiated which is reflected in the fixed assets account (see Note 3). The payment of the majority of the tenant improvement is deferred and payable over the life of the lease contract including the extension periods.

#### (6) SUBSEQUENT EVENTS

During the years 2013 and 2014 a major retrofit for earthquake protection and an expansion of the building was carried out. The construction was substantially funded with short-terms loans from a local bank and the construction company. On August 22, 2014, the various short-term loans were converted to an 8-year mortgage with monthly payments of \$34,010 and a final payment of \$4,889,827 on August 7, 2022. But a conditional option is in place to extend the mortgage with an additional five years, if the lease mentioned in Note 5 is also extended.

## PRESIDENT'S VISION

As artists and art aficionados we constantly exercise our creative and innovative skills. We, PAL members and supporters, are facing a unique opportunity to look into the future and assess what PAL might be in our second century. The opportunity and the options for capturing it are huge. We have just completed the building project. We are enjoying the first floor of this restored, renovated and seismically upgraded building. Our clear number one priority is to identify the path to occupying the entire building. This would more than double the floorspace available for studios and galleries. Since we own the building there will never be an issue of rent or affordability. The immediate challenge is clear but somewhat daunting — how do we raise sufficient money to pay off our mortgage and thereby enable total occupancy? Be a part of realizing a dream.

# IN MEMORIAM

### Remembering Helen Virginia Smith: PAL Past President 1982-1984

Helen Virginia Smith, a teacher, artist and Palo Alto resident for 60 years, died on July 12, 20014. She was 92.

Born Helen Rising on Oct. 18, 1921, in Champaign, Illinois. As a child, her family moved to California, where she was raised in Beverly Hills. In her youth, she played piano and learned to act. At Beverly Hills High School she performed alongside entertainer Betty White in a production of "Pride and Prejudice."

In September 1940, she married Phil de Barros, a former high school classmate, with whom she had two children, Philip and Paul. The couple divorced in 1948, and she went back to school at UCLA to earn a teaching degree. There she met Hershel D. Smith, who was studying chemistry, and they married on August 12, 1951.

In 1952 the family moved to Menlo Park, so that she could take a position teaching first grade in the Ravenswood School District and Hershel could continue medical school. They moved to Palo Alto in 1954. She taught for five years at Willow, Costaño and James Flood elementary schools before she began working in the district office, helping teachers with their reading programs. She retired around 1976.



Later in life she became involved with the Pacific Art League (then known as The Palo Alto Art Club), studying with Howard Brodie, Mitchell Johnson and others. Helen loved the watercolor medium, as well as sketching and sumi-e brush painting. She was president of the club for two years, beginning in 1982.

Let us remember her love and support of the arts and the Pacific Art League. Our thoughts and prayers are with her family.
